OFFICIAL RULES

These Official Rules (“Rules”) govern the Promotion. If you do not agree with these Rules, do not participate in this Promotion or accept a Promotion Giveaway (defined below). Participation in this Promotion (including any acceptance of a Promotion Giveaway) is deemed acceptance of these Rules.

1. GENERAL

1.1 Description of Promotion. Each end user customer who purchases an Eligible Product (identified in Section 2.1 below) from an Eligible Reseller (as defined below) during the Promotion Period (defined below) and submits the proof of purchase online as instructed below, will receive a complimentary choice of digital voucher/ eGift Card (the value of the eGift card for each Eligible Purchase is defined below).

1.3 Purchase Period. 1.6 Exclusions.
